# October 17th CSA Meeting Notes—Curt Larsen

This was a Zoom meeting from 9am to 11am Saturday October 17th.

The Safety presentation discussed riding with care in recent burn areas and also provided a summary from CAIC of 2019-2020 avalanche statistics.

CSA lifetime memberships don't exist, but many clubs offer lifetime memberships independently and pay the CSA dues yearly for lifetime members.

We have a new clerk, Jennifer Paddock, and she is up and running. She is currently updating the mailing list. The new CSA mailing address is PO Box 575 Hartsel, CO 80449.

The grooming clinic is being affected by Covid. It will be in Grand Junction when possible, date pending. It was scheduled for Nov. 1<sup>st</sup> but we will have to wait and see. As of Oct. 27th, the grooming clinic has officially been cancelled for 2020 and will resume next year. Piston Bully will host in 2021, Prinoth in 2022.

Great American Outdoors Act, is available for grants. We are looking into how to apply. Approval is long and money is tight.

The CSA Raffle is still being decided. As of now it is still moving forward, but the raffle will be held at the 2021 Spring Fling.

CSA is helping with an "outdoors video" for the Colorado tourism board.

The winter convention is not expected to happen in the usual format. The CSA meeting will be a separate Zoom meeting. Regional rides, North, Central, and South are being considered instead of the usual weekend event to be held early in February. Jim Lokey, has volunteered to head organization for the southern region ride possibly to ride Molas. More information will be provided as details firm up.

The Snow Scoop is no longer being published and the CSA officers are considering updating the CSA website and rolling in some new version of the Snow Scoop into the website.

CSA elections will take place at the winter meeting. The office of VP is up, and current VP Randy Miller is willing to accept another term. All odd year district reps are up for election. William Hall is our club's current rep, and he is term limited. Bylaws allow another term if no one wants to serve from our district. The district rep responsibilities include:

- The District Representatives shall serve as voting members of the Board of Directors and voting members of the Executive Board.
- Each District Representative shall have one
   (1) vote on all business of the Board of Directors and Executive Board.
- 3. Each District Representative must be a member of a Local Club in the district he/she represents.
- Each District Representative shall maintain all CSA assets and equipment in good working condition, consistent with established budgets.
- 5. Each District Representative shall turn over all association records and property to his/her successor at the time he/she leaves office.
- 6. District Representatives shall communicate pertinent CSA information to all Local Clubs in their districts.
- 7. May serve on committees and/or chair committees.
- 8. Shall present to CSA all Local Club directives, inquiries and concerns from within his/her district.
